### **I. NAME**

The Name of the Association is "Association of Lady Entrepreneurs of India" (ALEAP-India)

### **II. OFFICE**

The Office of "Association of Lady Entrepreneurs of India" is located at 8-2-120/86/9/A/30,Road No.2, Banjara Hills, Behind LUCID Diagnostics, Hyderabad-500034

### **III. OBJECTIVES:**

1. To Develop entrepreneurial skills in women and assist them in starting their own industry
2. To arrange and organize training programmes, Seminars and Conferences in the field to taxation, finance, exports and management for imparting skills/education
